INTRODUCTION

With passage of the North American Wetlands Conservation Act in December 1989, the infrastructure of the North American Waterfowl Management Plan (NAWMP) intensified. To the uninitiated, the administrative relationships were complex and overlapping. For those contemplating NAWCA grant application, the course was uncharted. Clearly, there was a need for a concise desk-top reference outlining the structure and mandate of the various councils, committees, commissions and boards involved in implementation of the North American Wetlands Conservation Act and the North American Waterfowl Management Plan.

This document was developed as an internal briefing paper for state and provincial fish and wildlife agency directors. Release of an earlier draft prompted a call for wider circulation among other organizations and individuals.

This reference guide is intended to assist existing and potential NAWMP partners understand the intricate, largely ad hoc, organizational structure associated with implementation of the NAWMP and the NAWCA in Canada, the United States and Mexico. Periodic updates of this document are planned given the dynamic nature of these organizations.

For purposes of voting on projects under the North American Wetlands Conservation Act, the Chair of the North American Wetlands Conservation Council (NAWCC) and one other member of the NAWCC (as chosen by the Chair of the NAWCC) are also ex officio members of the MBCC.

Mandate:

The Migratory Bird Conservation Commission was established under authority of the Migratory Bird Conservation Act (1929) to approve areas recommended by the Secretary of the Interior for migratory bird refuges and to fix the price at which lands may be purchased or leased.

Under the North American Wetlands Conservation Act (1989), the MBCC is further authorized to approve, reject or reorder the list of priority wetlands conservation projects submitted to it by the NAWCC; and further, by approving such projects, provide for federal funding of those projects.

Mandate:

As provided in the North American Wetlands Conservation Act (NAWCA) (1989), the Secretary of the Interior appointed the nine-member NAWCC in February 1990 to evaluate wetlands conservation projects according to criteria in the North American Wetlands Conservation Act and to assign priorities for their funding and acquisition. Composed of federal, state and private members, the NAWCC will recommend, in priority order, projects to the Migratory Bird Conservation Commission for federal funding. As provided for in Section 4 (g) of the NAWCA, the Director of the USFWS appointed a Council coordinator who is responsible for facilitating the consideration of wetlands projects by the Council and otherwise assisting the Council in carrying out its responsibilities under the NAWCA. The coordinator and various support personnel are headquartered in the North American Waterfowl and Wetlands Office (NAWVO) in Arlington, Virginia.

Mandate:

The North American Wetlands Conservation Council (Canada) is the senior Canadian body advising the Minister of the Environment on all aspects of coordinating and managing the funding, implementation and evaluation of Canadian habitat joint ventures under the NAWCA. The NAWCC (Canada), accountable to the Minister of the Environment, provides national leadership on all matters related to habitat joint venture coordination, evaluation, financial management, planning, and accountability. The Council is the principal point of contact with the NAWCC for all aspects of US approval and funding of Canadian joint venture projects. The NAWCC (Canada) also serves as the national coordinating committee for the development and implementation of wetland conservation policies and programs on both the national and international fronts.

The NAWMP Office in Ottawa serves the NAWCC (Canada). It is supported by a Secretariat jointly resourced by NAWMP partners including Environment Canada and Ducks Unlimited Canada. The NAWCC (Canada) has established the Canadian Wetlands Conservation Task Force reporting to the Council. This Task Force is leading the follow-up to the 1990 Sustaining Wetlands Policy Forum in conjunction with economic sectors in Canada and the National Round Table on the Environment and the Economy.

The NAWMP Committee, reporting to the Director General of the Canadian Wildlife Service and the Director of the US Fish and Wildlife Service, serves as the international board of directors for the NAWMP. This is a joint body that tracks the status of waterfowl and their habitats and assures that issues pertaining to implementation and evaluation of the NAWMP are brought to the attention of the USFWS and the CWS. It monitors and updates the Plan, its goals, objectives and structure and reviews new proposals and joint ventures. The NAWMP Committee also provides an international forum for considering technical issues affecting the accomplishment of Plan objectives. The North American Waterfowl and Wetlands Office (NAWWO) in Washington, DC and the NAWMP Office in Ottawa, Ontario serve as the executive secretariat to the US and Canadian sections of the NAWMP Committee, respectively.

Mandate:

This committee of the IAFWA was established as an ad hoc committee in 1987 at the request of Past-IAFWA President Gary Myers. The purpose of the committee was to assist in the implementation of the NAWMP which had been signed by the governments of Canada and the US in May 1986. Of specific interest was the implementation of First Step NAWMP projects in Canada such as the Quill Lakes project. The committee was charged with identifying ways of obtaining funding for the Plan. It was also to work with the Legislative Committee of the IAFWA to seek Congressional authorization to make the funds available. In this regard, the committee was directed to further develop the funding proposal involving state, private sector, National Fish and Wildlife Foundation, and Canadian funds which would later become known as the First Step Partnership.

It was also the role of this committee to advise the IAFWA on any and all matters pertaining to implementation of the NAWMP. In March 1991, the ad hoc status of this committee was dropped and full committee status granted in light of the continuing role for this committee in NAWMP implementation and funding activities.

Mandate:

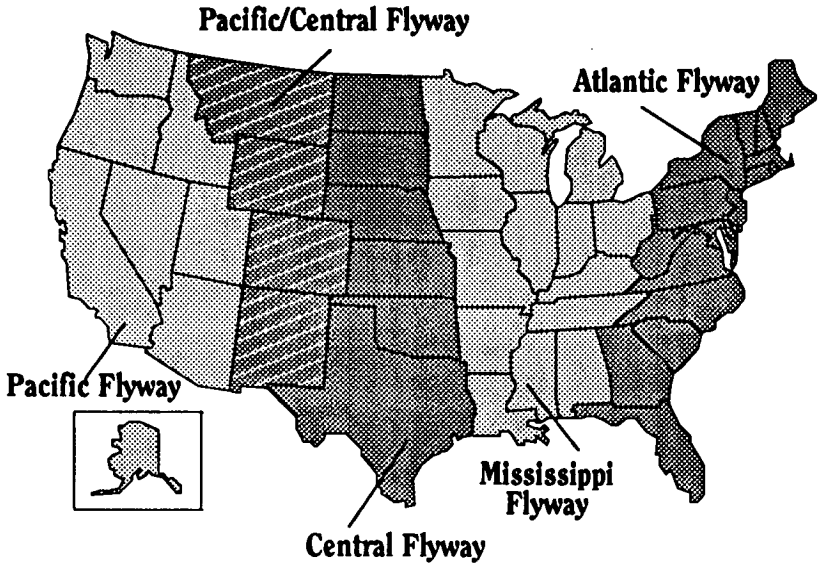

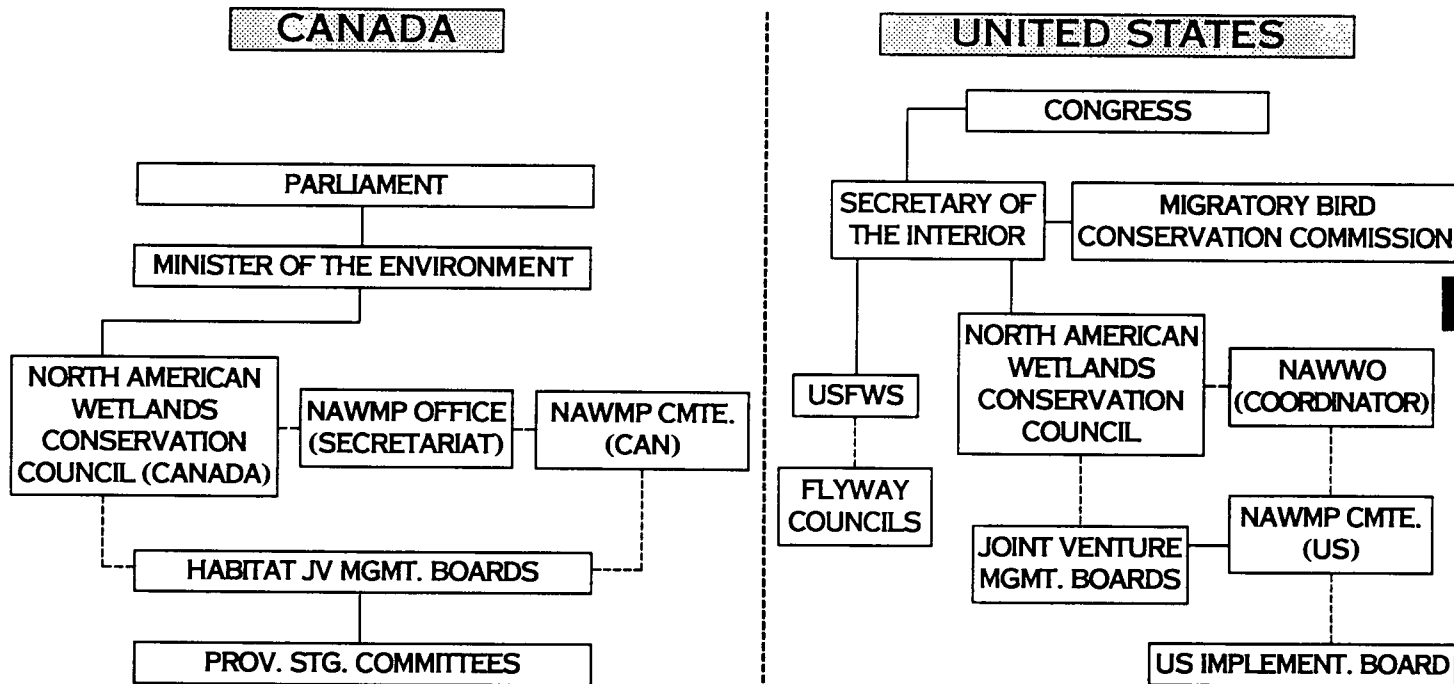

Mandate:

It was at the 41st Convention of the International Association of Game, Fish and Conservation Commissioners in 1951 that the states recognized a need for cooperative management of waterfowl and for a forum that would promote their interests in the regulatory process. A year later, Flyway Councils were established to deal more effectively with migratory waterfowl research, management problems, and programs. Under their bylaws the Flyway Councils have the responsibility to represent their member states on matters regarding cooperative state-federal management, research, and utilization of migratory waterfowl within each of their respective flyways. The USFWS appointed representatives to serve as liaison with the Councils and enlisted representatives from the Councils to serve as consultants on regulatory matters through formal memoranda of understanding. The strength of the Flyway Council structure has grown in stature and influence over the years.
